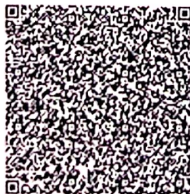
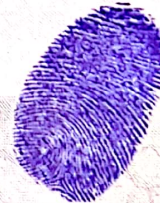

Hereinafter jointly called the settlors/founders of the Trust, Which expression shall unless excluded by or repugnant to the context or contrary to the meaning there to include their heirs, successors, executors, administrators, etc. of the one part.

Hereinafter collectively called the Trustees which expression shall unless excluded by or repugnant to the context or contrary to the meaning there of include then respective heirs, successors, executors, administrators etc. of the second part.

estate, right, title, interest, claim and demand of the settlers together with all income, issues, thereof and all additions and accretions there to and all accumulations thereof and all the investments for the time being representing the same and conversion hereof and all movable and Immovable properties acquired thereby (hereinafter collectively referred as the Trusts Estate) unto and to the Trustees TO HAVE AND THE HOLD the said Trust Estate unto and to the use of the Trust upon and subject to the Trust's powers and provisions hereinafter declared and expressed by and between the parties hereto as follows :

2. NAME OF THE TRUST :

The name of this Trust shall be **SHREE RAGHUNATH KRIPA TRUST.**

3. REGISTERED OFFICE :

The registered office of this Trust shall be situated at **RAMSAGAR DHANI, JORPURA MODE KE PASS, DUNGREE, JAIPUR, 303328, Rajasthan** However, the Founder Trustees named herein above may change the registered office the Trust to any other place/s asthey may desire to fulfil the obligations cast on them.

4. OBJECTS:

The objects of this Trust shall be:

- a) To Organize Religious And Social Events.
- b) To promote Gau Seva in Society.
- c) Granting of financial assistance to any educational institution for granting scholarships, prizes, medals, awards for excellence in sports.
- d) To give scholarship, prizes to deserving students, scholars and teachers to support or assist by grants or otherwise, schools, colleges, universities and professional institutions promoting Sports activity and encourages the students to Participate in such recreational activity.
- e) To take over or merge with other institutions of similar ideology for the attainment of above objects.
- f) To promote sports, games, contests, matches, or creative activities, and to establish, sponsor, support or assist, by grants or otherwise, gymnasiums, playgrounds, swimming pools or other means of improving the physical well being of the people.
- g) To provide free food, clothing and shelter to the poor and needy or to the victims of famines, droughts, earthquakes, floods or other natural calamities.
- h) To provide any other form of welfare and relief and assistance to alleviate distress and suffering, to provide crutches or other auxiliary aids to industrial or other workers and generally to sponsor, support or assist in all noble and charitable causes, children welfare programs and projects.
- i) To collaborate in kindred activities with other national or international organizations with similar objects.
- j) To takeover or amalgamate with any other charitable Trust, Association or Institution with similar objects.
- k) The activities of the Trust will be carried in India and outside India.
- l) To Provide Social Welfare And Human Welfare
- m) To Manage Environmental Protection And Security.
- n) To Protection And Enhancement Of Sanatan Dharma And Hindu Culture.
- o) The administration of the trust and the control, regulation, management and application of the trust fund shall as far as reasonably

5. POWERS OF TRUSTEES

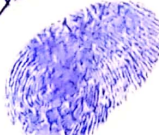
The Trustees shall have the following enabling powers to achieve or in furtherance of the above objects:

- (a) To administer the Trust, its properties and affairs and do all the things which will fulfill the performance of the objects for which the Trust is established and for this purpose the Board can apply the whole or any part of the Trust property towards the payment of the expenses of the Trust.
- (b) The income and the properties of the Trust will be solely utilized towards the objects of the Trust and no portion of it will be utilized for payment to the Settler, or Trustees or their relatives.
- (c) To open one or more bank accounts and operate the same or provide for operation of the said accounts by any two among them authorized on their behalf.
- (d) To invest the Trust funds in the manner not prohibited by any provisions of the Income Tax Act, 1961.
- (e) To buy, sell, mortgage, grant, lease, hire or otherwise alienate all or any of the properties of the Trust in its discretion for adequate consideration.
- (f) To execute power of attorney or powers of attorney to any person for the purpose of executing, administering or managing the whole or any part of the Trust for the purpose of all or some among the objects of the Trust.
- (g) To borrow money with or without security and to repay the same.
- (h) To receive, collect and enforce recovery of all monies due or payable to the Trust and grant receipts and discharges therefore.
- (i) To settle, compromise or compound any disputes or refer the same to arbitration or litigation.
- (j) To receive voluntary contributions from any person or persons from India or outside, after complying with the statutory formalities, by way of donation, gifts or in any other manner and to hold the same upon Trust for the objects set forth herein.
- (k) To appoint, suspend, dismiss or otherwise deal with the staff required for the administration of the Trust, to frame rules relating to their salaries and other benefits and generally to exercise all powers ancillary and incidental to effectively carry out the objects of the Trust.
- (l) The Board shall have power to make and rescind rules and regulations

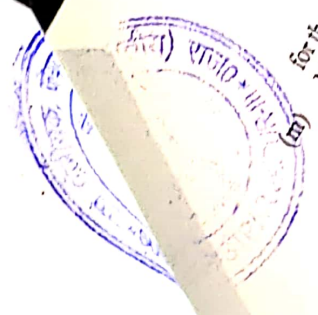

- (m) No Trustee shall commit any act or breach of Trust of the Trust fund or property or cause any loss to the Trust property or commit fraud in the administration of the Trust fund / property.
 - (n) The Trustees shall hold honorary office and shall not be entitled to any Salary, allowances or perquisites, except for the reimbursement of actual expenses incurred in connection with attending to the Trust matters.
 - (o) The Board of Trustees will follow the instructions given by any donor who makes substantial contribution towards furtherance of the objects of the Trust, so long as such instructions are not detrimental to the attainment of the objects of the Trust and are in conformity with the provisions of the Income-tax Act, 1961.
 - (p) For the management and administration of the Trust, the Trustees shall elect one amongst themselves for each of the offices of **Secretary and Treasurer**. The term of office for Secretary and Treasurer shall be for a period as may be decided by the Board of Trustees. No Trustee including the **President** shall hold more than one of the above offices at the same time. The persons holding these offices of Secretary and Treasurer shall be under the administrative guidance and supervision of the President and will report to him directly.

6. No member shall have any personal claim on any property of the Trust or make profit out of his membership. The income and property of the Trust shall be applied solely towards the promotion of its objects and no portion thereof shall be paid or transferred directly or indirectly in any manner whatsoever to the members or past members of the Trust or to any persons claiming through any one or more of the members.

7. CORPUS OF THE TRUST

The corpus of this Trust shall be the money that is settled to this Trust and handed over by the Settlers to the Trustees of this Trust. Also includes in the corpus of the Trust such property or properties both moveable and immoveable, voluntarily transferred to this Trust by any person/s with the specific direction that such contribution/s should from part of the Corpus of this Trust.

RULES AND REGULATIONS

GOVERNING COUNCIL

- (a) The Trust shall be vested in and managed by the Board of the trustees.
- (b) The first trustees of the Board shall be the following persons who shall hold the office of the trustee for their life or till such time that any of them resign from the post of the trustees:

1. Shri RAM LAL MAHALA S/o KISHAN LAL MAHALA
2. Shri RAMKARAN CHOUDHARY S/O NARAYAN LAL GHASAL
3. SMT. SITA DEVI W/O RAMLAL

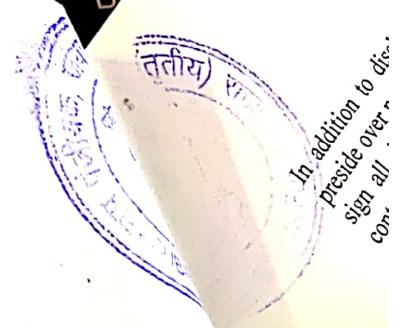
(C) PRESIDENT/ CHAIRMAN/MANAGING TRUSTEE:

In addition to discharging normal duties of a trustee, the President shall preside over meeting of the Board of Trustees. The President is authorized to sign all documents, including bank documents, acknowledgements for the contributions received, and agreements with individuals, Government Institutions and other organizations, on behalf of the Board of Trustees. The President shall have all the residuary powers, not explicitly assigned to any of the other officers in these presents.

The President is authorized to sign along with the Treasurer bank cheques, deposit release vouchers etc. The President is empowered to remove any Trustee from the Trust and its offices, if he/she finds that his/her activities are not congenial to the activities of the Trust.

The President is responsible for ensuring that the Trust pursues its Objects and for maintaining the dignity of the Trust organization and shall use his/her influence to promote the activities of the Trust.

(D) SECRETARY:

The Secretary shall maintain the records of the organization prepare and circulate agenda and minutes of Board of Trustee meeting for the approval of the President.

The Secretary shall be also responsible for the day to day administration activities of the Trust. The Secretary shall deal with correspondence received by the Trust, send replies in consultation with the President, and/or the Treasurer where necessary. He/she is responsible for the safe custody of all the properties and records of the Trust. The Secretary shall represent the Trust in all legal matters, sign the papers related to legal cases, attend to courts or represent the Trust in Government offices.

(E) TREASURER:

The Treasurer will prepare Annual Budget, monthly and yearly expenditure statements get the expenditure audited by auditor duly appointed by the Board of Trustees and place them before the Board of Trustees for approval. The Treasurer is responsible to maintain cash book and prepare vouchers for the payments made, receive contributions, sign acknowledgements for the amounts or articles received by the Trust and prepare monthly and yearly statements of revenue and expenditure, as well as, the register of assets of the Trust and place them before the Board of Trustees for their approval.

The Treasurer is authorized to sign bank cheques, application for drafts and payment instructions jointly with the President and draw money from the bank, upto the limits defined by the Board of Trustees in their meetings. The Treasurer is responsible for safe custody of cash, bonds, securities etc. of the Trust.

- (F) Any vacancy arising in the Board of this Trust shall be filled up by the remaining trustee/s and such nominated person/s shall hold office for such term as the Board may fix.
- (G) The Founder Trustees shall have powers to appoint further trustees so that a certain time the minimum number of trustees may not be less than 2 and not more than 20. Later on, in case of necessity, increase in number of trustees from 20 may be thought over.

(H) Other Trustees

The other trustees so nominated/ appointed shall hold office from close of Annual General Meeting at which they are elected for the term as may be decided by the board of trustees and thereafter they will automatically retire by rotation. However, the retiring trustees are eligible for re-nomination /

(I) **Co-opted Members**

The Governing Council may co-opt, as and when it deems necessary, not more than 3 persons, but without the right of vote. Co-opted members shall hold office for the period for which they are co-opted by this period will not exceed 2 years.

MEETINGS

All meetings of the Trust shall be called by notice under the hand of either the President or the Managing Trustee.

QUORUM

Two trustees of the Trust shall form a quorum at a meeting of the Governing Council. In the absence of quorum, the meeting can be adjourned for 1/2 hour and for such adjourned meeting no further notice or quorum is required.

The voting shall be by show of hands. No member shall have more than one vote except that in any case of equality of votes on a division, the president/ chairman shall have a second or a casting vote.

MINUTES

Minutes of the proceedings of every meeting of the trustees shall be entered in a book to be kept for that purpose and this shall be signed by the Chairman of such meeting or of the next following meeting when they are read over and confirmed and shall when so entered and signed by conclusive evidence of the business and other matters transacted at such meeting.

POWERS & DUTIES OF THE GOVERNING COUNCIL

The Governing Council shall have the power to regulate its own procedure and shall subject to the provisions of these presents, have the sole control and management of the income, property and affairs of the trustees, and may exercise all powers and do all acts and things that may be exercised or done by the trusts and not by law or by these presents required to be exercised or done by the trust in general meeting.

BENEFICIARIES OF THE TRUST:

The Trust is established for the benefit of citizens of India and the class of people mentioned above without discrimination of caste, religion, creed or sex.

FINANCE, ACCOUNTS AND AUDIT

ACCOUNTS

The Managing Trustees shall receive all sums of money due or payable to the trust and deposit them forthwith, with the bankers of the trust. All amounts required for expense or other disbursements shall be withdrawn from the bankers. They shall keep or cause to be kept a proper account of receipts, payments and expenditure of the trust, and of other matters in respect of which such receipts or payments take place, and the property, assets and liabilities of the trust in proper books of account and shall produce the account books, properly posted up, when required by the Governing Council or the auditors. They shall also cause to be placed before the governing council or any of its committees, such periodical reports, statements and abstracts of accounts, as may be required by them. However, the Managing Trustees shall have the power to delegate such of his functions as may consider necessary for any specific occasion or purpose except that he cannot appoint anybody as Managing Trustee of the Trust.

INVESTMENTS

All sums of money not required to be applied immediately or at an early date for the purposes of the trust, shall, subject to any direction contained in the instrument of trust or donation or transfer on favour of the trust, be placed in deposit accounts with any of the Nationalised Banks, Body Corporates approved the Governing Council or invested in any one or more securities.

The Governing Council may from time to time realise and/or vary such investments.

AUDIT

The accounts of the Trust shall be made up to the close of the financial year of the Trust, which shall be from April 1 to March 31, shall be audited by the Auditors of the Trust. The initial financial year shall start from the date of incorporation of the trust upto March 31 next to the date of incorporation.

The Managing Trustees shall be responsible for the proper maintenance of accounts, investment and audit, completion of all the legal formalities and other trustees shall not be answerable to anyone as far as these matters are concerned.

BANK ACCOUNT

The Bank Accounts to be operated by any of the 2 trustees, out of which one would be either the President and/or the Managing Trustee, and in case of necessity (i.e. in the absence of President or the Managing Trustee) another Trustee.

REVOCABILITY

This Trust shall be irrevocable.

AMENDMENT

The Board of Trustees shall be at their sole discretion to amend any portion/s of this Trust-Deed to achieve the objects of this Trust but however, such amendments shall not infringe the provisions of Section 2(15), 11, 12, 13 and 80G of the Income Tax Act, 1961.

INDEMNITY


Every member of the Governing Council or any other persons employed by the Trust or Auditors of the Trust shall be indemnified out of the funds of the Trust against all losses and expenses incurred by him in or about the discharge of his duties in defending any proceedings, civil or criminal, in which judgement is given in this favour or in which he is acquitted or in any other manner except such as may happen from his willful default. No member of the Governing Council or other officer shall be liable for any other Member of the Governing Council or Officer of for joining in any act or receipt, or for act or conformity of for loss occurring to the Trust unless it shall be due to his own willful default.

Further, the trustees for the time being of these present, shall be respectively chargeable only for such of the Trust funds and properties and income thereof including money, stocks, funds, shares and securities as they shall respectively actually receive, notwithstanding their respectively signing any receipt for the sake of conformity and shall be answerable and accountable only for their own acts, receipts, neglects or defaults and not for those of each other, nor for any banker, broker, auctioneer or agent or any other person with whom or into whose hands the trust properties or any part thereof may be deposited or come, nor for the insufficiency or any deficiency of any such stocks, funds, charges or securities, nor any loss nor for commission or omission of any act not amounting to breach of trust, unless the same shall happen through their own willful or dishonesty respectively.

CONTRACTS AND DOCUMENTS

All contracts, transfer deeds or other documents necessary for purchase, sale or alteration of the investments of the Trust shall be executed on behalf of the trust by the President or the Managing Trustee of the Trust and counter-signed by a member of the Governing Council.

SUITS AND PROCEEDINGS

The President and/or the Managing Trustee shall have the power to file or defend suits or other proceedings on behalf of the trust and shall have power to compromise, settle or refer to arbitration any dispute relating to the trust.

DISSOLUTION

If on the winding up or dissolution of the trust there shall remain after the satisfaction of its debts and liabilities any property whatsoever, the same shall not be paid to or distributed among the members of the trust, but dealt with in such manner as the trust may determine, provided, however, that the assets be used in such manner as to further as nearly as possible the objects for which the trust was established. Upon such resolution of the trust its assets will be transferred to a Registered Trust with similar objects.


